



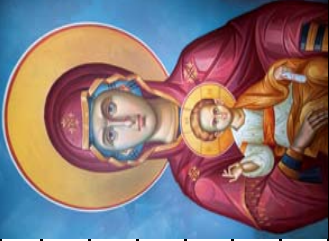

2018 STEWARDSHIP FINANCIAL COMMITMENT

The approximate operating budget for St. Nicholas in 2018 will be \$596,000 which includes \$273,000 for personnel, \$109,000 for repairs, maintenance, and utilities, \$131,000 for Archdiocese and Metropolis commitments, \$26,000 for ministries, \$24,800 for office expenses, and \$33,000 for other expenses. We hope and pray you will do your best to help us meet our needs for 2018. On the average, about \$2,000 is needed per family/individual to meet our budgetary needs based on 300 stewardship pledges.
